


- IREx no longer requires institutional portal agreement HRPP/IRB managers or directors can request access via website: https://redcap.vanderbilt.edu/surveys/?s=W98HMCHAPT
- Established "IREx Study Manager" role for CCCs and Lead Study Team Coordinators to help with single IRB coordination
- Improved "IREx Study at your site" email: (1) local study PI is always noted and (2) highlight importance of local study team and local HRPP connecting around sIRB studies

Tracking Component Sites

USING IREX TO TRACK COMPONENTS

• FWA sites can list their components in IREx

- + Delineate where research is happening
- + Allows for multiple, separate study teams to be engaged on the same study



 Component sites DO NOT have liaisons or Institutional Profiles – the FWA site's liaisons perform all actions in IREx for their components sites (e.g., ceding review, providing local considerations)

TRACKING LETTERS OF INDEMNIFICATION (LOIs)

- Some institutions require an LOI given that SMART IRB is silent on indemnification
- IREx will allow for tracking of institutional-level LOIs
 - Cannot have different LOIs for different studies
- Internal and External LOI tracking
 - Sites who have signed your LOI
 - External LOIs you signed





Capturing Local Considerations

USING IREX TO CAPTURE LOCAL CONSIDERATIONS

- SMART IRB Agreement | 6. Responsibilities of the Relying Institution(s) Section 6.4 "Local Considerations"...[Each Relying Institution will...] Communicate to the Reviewing IRB the requirements of any applicable state or local laws, regulations, institutional policies, standards, or other local factors, including local ancillary reviews, relevant to the Research ("Local Considerations") that would affect the conduct or approval of the Research at the Relying Institution. Such communication may be made through the Reviewing IRB's designee, as determined by the Participating Institutions in connection with the specific Research.
- Reviewing IRBs can use IREx to centralize this documentation for their studies
 - Standardizes the *questions* asked of Relying Sites
 - Standardizes the *process* of providing local considerations
 - Ensure *local HRPP involvement* in the reliance process
 - Facilitate *site-specific tracking* and documentation on a study-by-study basis



USING IREX TO CAPTURE LOCAL CONSIDERATIONS

The Reviewing IRB or Lead Study Team/Coordinating Center can tracking Local Considerations in IREx

Once complete for a site, surveys are exported and submitted to sIRB system for review.
