
#### **MORE AGREEMENT OPTIONS**



SMART IRB Agreement Versions 1 and 2 (Released Oct 1, 2020) Other Reliance Agreement (e.g., IAAs, MOUs) for sites who are unable to sign on to SMART IRB Indemnification terms or Letters of Indemnification (LOI), if required in addition to the reliance agreement

#### **SIRB Sets Up Agreements**

- Ability to offer SMART IRB Agreement, an Other Reliance Agreement, and indemnification on the same study.
- If SMART IRB and an Other Reliance Agreement are offered on the same study, sites in SMART IRB will default to SMART IRB for the study.
- If the reliance involves the NIH Intramural Research Program, both the Reviewing IRB and Relying Institutions will be required to use SMART IRB version 2.
