## Study Managers can Upload Continuing Reviews / Amendments

Originally: sIRB had to upload overall approval for continuing review and studywide amendments. Then, Study Managers could upload site-specific approvals.

To save the sIRB time,


Study Managers can now upload the overall and sitespecific approvals for continuing reviews and study-wide amendments.





# Looking Bright in 2021 – New System Features




- 1. SIRBs can offer SMART IRB + an IAA on the same study. (Sites in SMART IRB will default to that agreement.)
- 2. SIRBs can add an IAA to an <u>existing</u> IREx study.
- 3. Reliance and indemnification agreements can be study-specific or broad in scope.







Summer 2021: Allowing sIRBs to document site and study closures

Fall 2021: Reorganize how approvals are stored and accessed by study teams



Winter 2021: API Phase V – Pushing any type of approval to IREx (not just Initial approvals for lead + Psites)
