





IREx – The PIDTC Experience

A little about our Consortium...

- The Primary Immune Deficiency Treatment Consortium (PIDTC) is a network of 47+/- immunology and hematopoietic stem cell transplant (HCT) centers throughout the USA and Canada that was established in 2009
- We have 3 natural history or observational studies that collect data on patients with Primary Immune Deficiencies (PID) from the clinical visits related to their ongoing care and treatment
- This involves collection of current and historical medical history from electronic - and sometimes paper (!) – medical records, laboratory tests that capitalize on clinical blood draws, stool sample collections, and selfreport quality of life and socioeconomic status questionnaires

Use of IRBs for our protocols...

- Currently, there is a mandate for NIH-funded studies that ALL sites have to rely on a single IRB
- Previously, we had a mix of local HRPPs and single IRB for our previous protocols with almost as many sites
 - On the one hand, you could let the sites using their local HRPP fend for themselves, but on the other hand, you didn't have as much control over the content of consents and assuring that all sites were including all pertinent content
 - e.g. data sharing with other entities we didn't really have a final say in the language of consents

Our use of IREx...

► 3 large protocols at 47 sites:

Severe Combined Immune Deficiency (SCID) – 6 consents

Chronic Granulomatous Disease (CGD) – 3 consents;

Primary Immune Regulatory Disorders (PIRD) – 5 consents

SCID as an example of workload...6 consents x 47 = 282 consents to review; 3 IREx Surveys x 47 = 141 local considerations surveys to take into account; and 47 reliance agreements to get completed

Our single IRB contact said that it would be hard at the beginning, but that we would thank ourselves for using IREx as we continued along...

Advantages so far...

One-stop shopping

- All sites doing the same thing, so a great advantage for our 3 protocols that all methods are the same for each protocol
 - Identify the key personnel, complete the Surveys, upload consents for local review
- Each site has their own local "platform" to access their own consents and other local materials
- Study-Wide platform so that our standardized forms, such as questionnaires, recruitment materials, etc. are loaded once and available to all the other sites
- No more emailing out local consents to all sites!
- User-friendly with good resource documents for step-by-step instruction as needed





 - Manage Agreements, if using non-SMART agreement or indemnification
- All: renaming 'Coordinator' to 'Study Team Member' to be more inclusive
